Details of the investment opportunity

- AMATI is a traditional Czech brand.
- The company previously ranked among the three largest manufacturers of its kind in Europe and exported products to more than 50 countries around the world. Founded in 1945, its registered office is situated in Kraslice in the Karlovy Vary region.
- In spite of its debts (financial obligations that arose prior to the sale of the debtor's business establishment are being settled in insolvency proceedings for the debtor's assets), the company, a manufacturer of woodwind musical instruments, has a healthy core in the shape of a unique product range and the company employees themselves.

Its product range can be divided into two basic groups of instruments. The first group contains woodwind instruments (e.g. clarinet, bassoon, contrabassoon and saxophone), while the second group consists of brass instruments (such as cornet, trumpet, flugelhorn, baritone horn, sousaphone and tuba).


The products are protected under the trademarks V. F. Červený & synové, AMATI and ak Amati Kraslice.

Top musicians and ensembles choose the company's products, which are exported and sold all over the world.

Czech musicians who choose Amati instruments include jazz trumpeter Laco Deczi, trumpeters of the Czech Philharmonic, the wind section of the band Chinaski, the band Kryštof, the popular brass band Mistřiňanka, and others.

The company is currently under the management of an insolvency trustee together with an experienced crisis manager and a team of key co-workers from the company staff; production is provided by loyal and qualified employees.

Description of the transaction

- Upon selling the debtor's business establishment under a single contract, all rights and obligations related to the sale, including rights and obligations arising from labour-law relations with the debtor's employees, shall be transferred to the buyer, except for liabilities of the debtor arising before the contract enters into force.


